While watching a friend practicing for an upcoming bonspiel, the first aid team witness an accident. In one lane, one of the players is preparing for his turn when he trips over a broom, losing control of the rock and falling on his outstretched arm. The rock strikes a teammate who is throwing his rock causing him to strike his head on his rock.

SCENARIO ONE

SIMULATOR'S INFORMATION

Casualty 1

closed fracture to left clavicle - small swelling (3 cm diameter) midpoint on clavicle with bruising

casualty complains of chest pain, is anxious and very pale with sweating

S - swelling /discolouration on clavicle, chest pain, very pale and sweating

A - none

M - nitroglycerin 0.3 ug with spouse (judge)

P - angina x 3yrs

L - breakfast - bacon and eggs toast and coffee

E - tripped on broom, fell to ice on outstretched arm

Positioning

sitting on ice, holding bent left arm at elbow, head inclined to the left side : one leg is extended over the other which is bent and under the other thigh

→

Casualty 2

closed fracture right patella - significant bruising present at site

5 cm laceration to left temple

S - bruising at right knee, bleeding freely from forehead, casualty complains of pain at knee, no loss of

sensation below injury

A - penicillin (with medic alert bracelet)

M - none

P - none

L - breakfast - coffee and doughnuts

E - hit by rock and fell forward hitting head on handle of his own rock

Positioning

lying on left side with his hands in front of his face; his right leg is extended with a slight bend at the knee, the left leg is flexed under his body

Equipment needed

4 rocks

2 brooms

masking tape to mark "lane"
