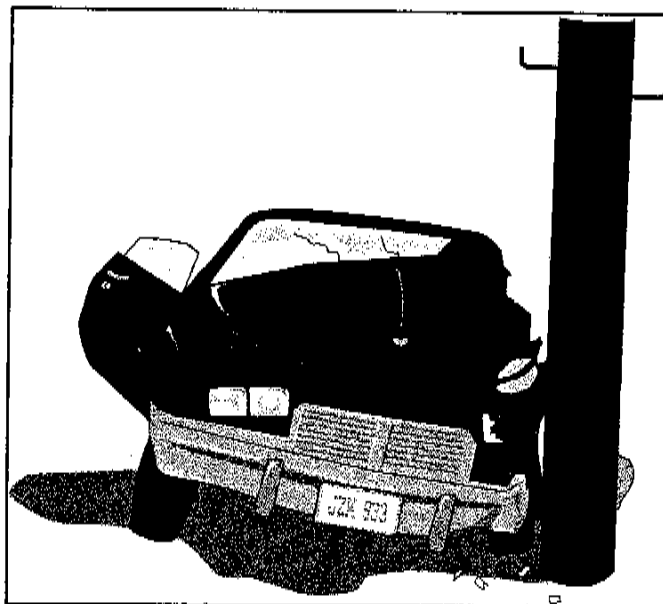

While driving down the road you notice a car ahead of you blow the right front tire. The car swerves off of the road to the right, through a ditch and comes to rest against a hydro pole. Left hand door is crushed when impacted with the hydro pole but , has been torn off the car for easy access. (two door car)

When approaching there is a strong smell of gasoline coming from the underside of the car. There also is a sign of steam coming from under the hood. Hood cannot be opened.

Coaching required - no fire extinguisher available
- windshield has been shattered allowing easy access



CASUALTY SYNOPSIS

DRIVER

- Unconscious
- Bruised right lower arm
- Head lacerations eyes unequal and sluggish
- Glass embedded in the face
- Fractured left lower leg
- Fractured left upper arm

Casualty Layout

Two chairs side by side representing the car, with duct tape used for a jammed seatbelt. This will force the First Aiders to cut the seatbelt off.

Casualty Vitals-pulse-weak and rapid

- respirations-shallow and rapid
- eyes-unequal and unreactive
- skin- pale, cool, clammy

5 min- car bursts into flames

15 min- car explodes indicating the end of the team scenario

CASUALTY SIMULATION REQUIREMENTS

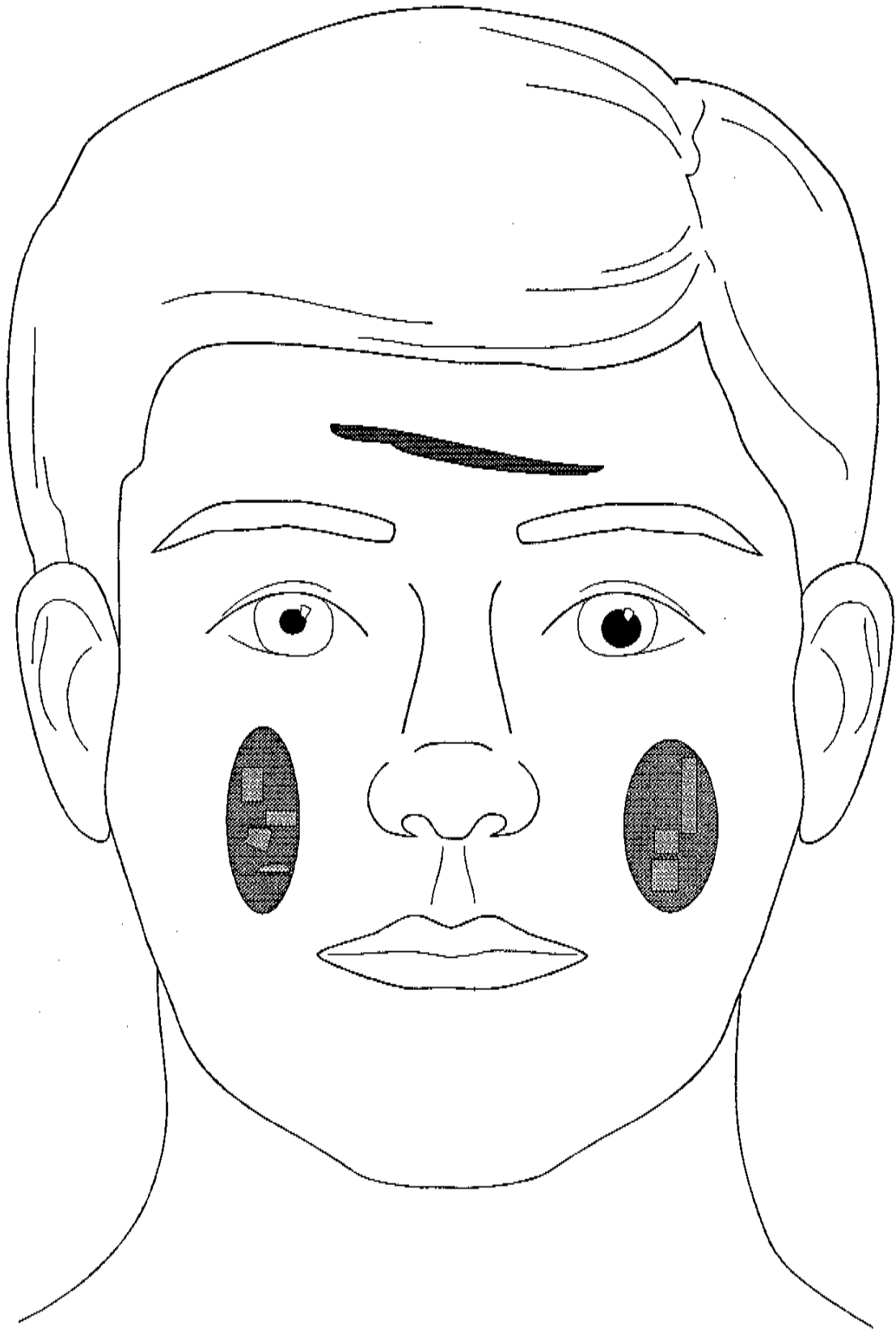
- plexiglass chips for glass fragments
- bones for open arm fracture

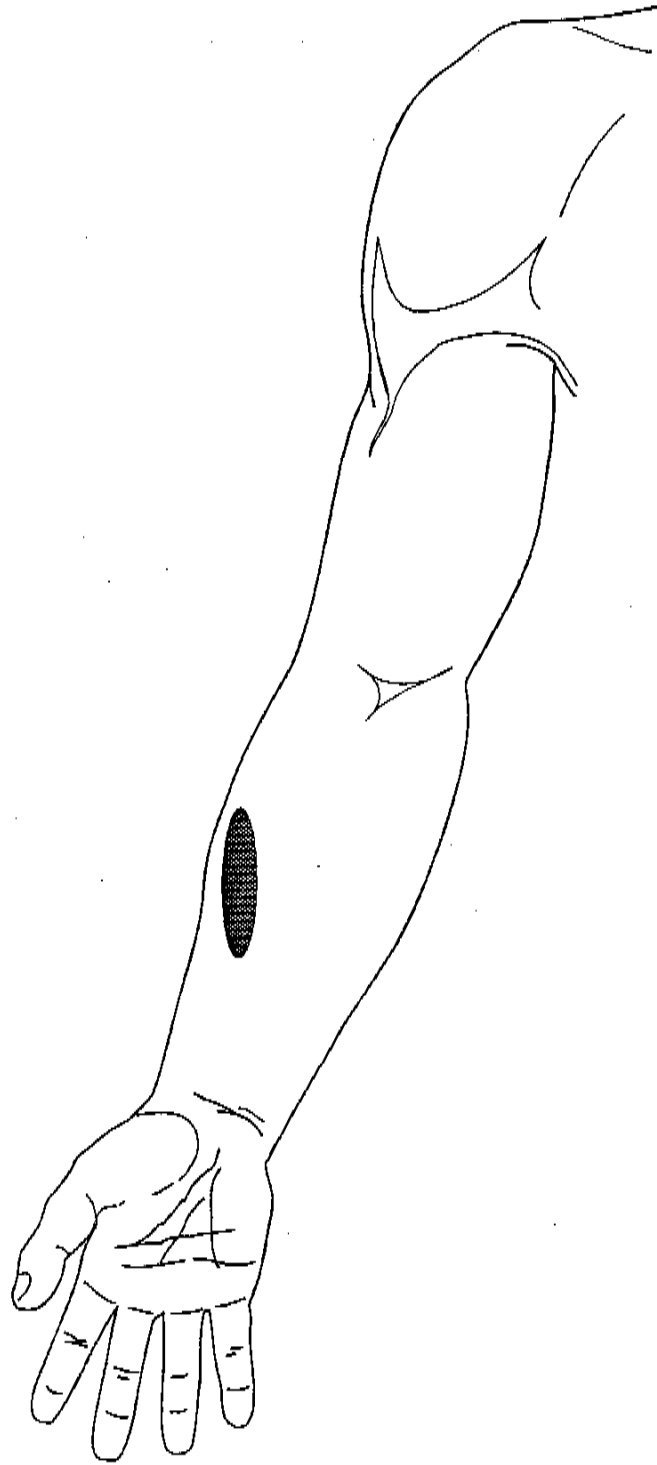
HEAD

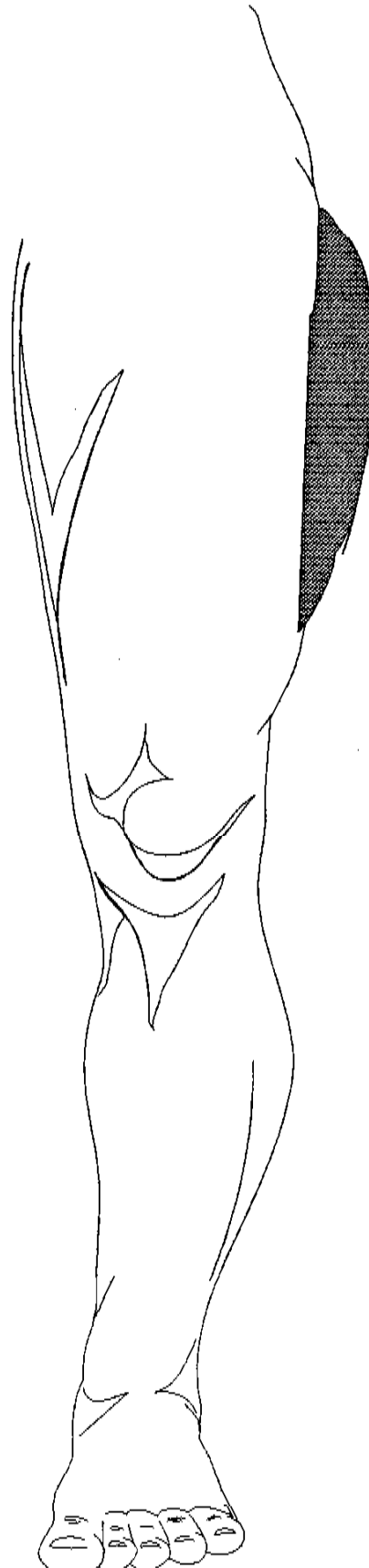
- laceration center of forehead 3 inches in length major bleed
- glass embedded in both cheeks with some dirt and blood
- left eye dialated and unreactive
- shock

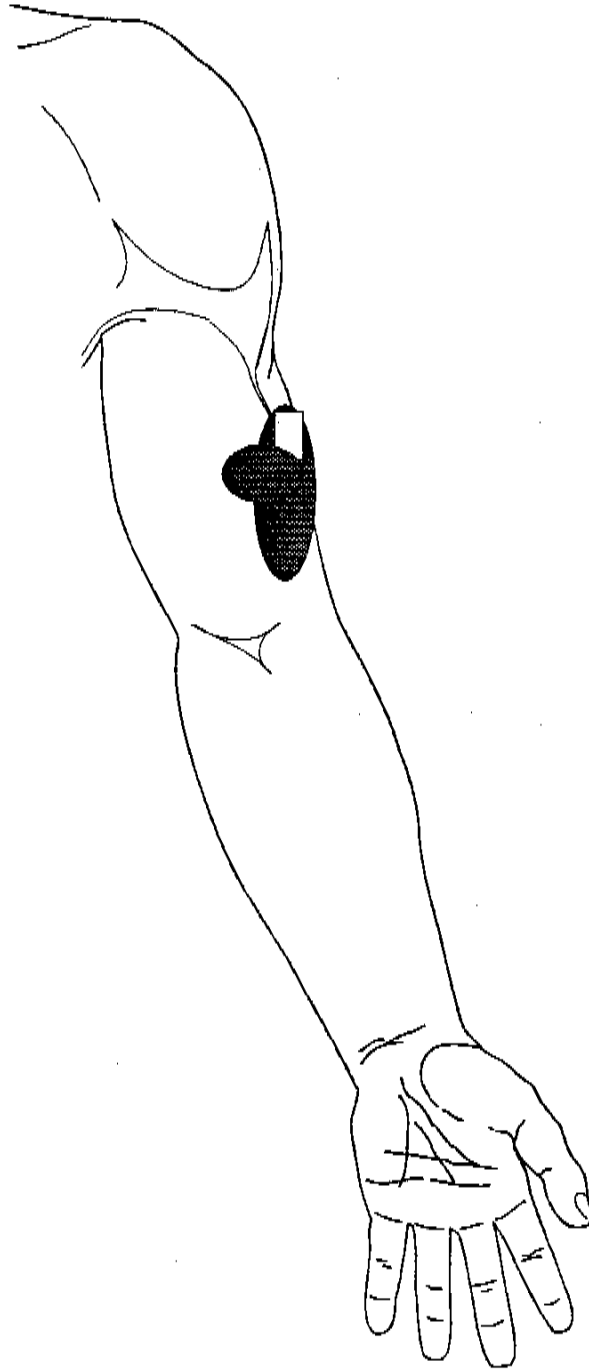
BODY

- fractured upper left leg - major discolouration
 - deformity approx. 3 inches in length and 1/2 inch in ht.
- fractured upper left arm - open fracture with minor bleeding
- bruised lower right arm
